Each volunteer must sign Love Is An | ART | Organization waiver and release form. This document must be received via email 24 hours before departure on Saturday, July 14th at 10:00AM.

Waiver and Release

I understand that these events will take place away from the city of Atlanta, GA. I understand that my I am expected to follow all applicable rules, standards, instructions and laws, including, but not limited to, those that pertain to riding in a motor vehicle and any other mode of transportation. I further understand that I am to behave responsibly and to follow the camp's discipline code and policies and to follow the directions provided by the organization's trip leaders and staff.

I understand that the organization's staff will do everything possible to prevent any accidents. However, I fully understand that some activities on camping trips involve inherent risks to volunteers regardless of all feasible safety measures that may be taken by Love Is an Art Organization including the risks associated with traveling to and from the location of the trip by walking, public transportation or other means and the possibility of bodily injury, emotional distress, and even death, incurred while transporting to or participating in the trip.

I agree that I am solely responsible for any loss, damage, or injury to myself that occurs during my participation in a camping trip even that is caused by the negligence of Love Is An Art Organization, Love Is An Art Organization or any educational program it operates or manages, their officers, trustees, directors, volunteers, agents, chaperones, or other affiliates (together, "Love Is An Art Organization") not including any loss, damage, or injury that is the result of gross negligence or willful misconduct of Love Is An Art Organization.

If my or our executors and assigns hereby agree to release, discharge, indemnify and hold harmless Love Is An Art Organization from any and all claims of liability, injury, or damage that we may have or that we could each bring on our own from or relating to or in connection with my participation in mentorship trips. I further agree to release and discharge Love Is An Art Organization from any claim that we may have or that we could each bring on our own, or on my own behalf, with regard to any damages, demands, or actions whatsoever, including those based in negligence, in any manner arising out of my scholar's participation in the field trips. This release and indemnification does not apply to claims for intentional misconduct or gross negligence.

Photography Release

I understand while participating in this activity, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

Consent to Medical Treatment

I agree that in the event of an emergency injury or illness and in the event that I cannot be contacted, the staff member(s) in charge of the trip may act on my behalf and at my expense in obtaining medical treatment for myself. I further agree that I release Love Is an Art Organization from any claim whatsoever that might arise on account of any such medical treatment.
